## Higher Education Emergency Relief Fund Report – CRRSAA-Emergency Financial Aid Grants to Students

The institution has used, or intends to use, no less than 50 percent of the funds received under Section 314(a)(4) of the CRRSAA Act to provide emergency financial aid grants to students.
